Attached is a check for the mandatory Delegate Fee of \$10.00. (Note: Only residents of the 4th District are eligible to be Delegates.)

SEVENTH DISTRICT VOTERS: *There be no 7th District Convention in 2018. Congressman Dave Brat was the only candidate who filed and was declared the Republican Nominee on January 29, 2018.*

PLEASE NOTE: Article VII, Section C of the Republican Party of Virginia's *Plan of Organization* states the following about membership on a county committee:

A member of an Official Committee is held to a higher standard of support for nominees of the Republican Party than an individual who merely participates in a mass meeting, party canvass, convention or primary. Therefore, a member of an Official Committee is deemed to have resigned his Committee position if he (a) makes a reportable contribution to and/or (b) allows his name to be publicly used by and/or (c) makes a written or other public statement in support of a candidate in opposition to a Republican nominee in a Virginia General or Special Election.

By signing this form, I certify that I am a registered voter in Chesterfield County, have read and understand the requirements above and that I intend to support all nominees of the Republican Party during this election (for convention delegates) and/or during my two-year term as a member of the Chesterfield County Republican Committee. Also, I have read and understand other requirements herein including, but not limited to Article 1 of the *Plan of Organization* which states in part:

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.
