**PLEASE NOTE:** Article VII, Section C of the Republican Party of Virginia's *Plan of Organization* states the following about membership on a county committee:

**A member of an Official Committee is held to a higher standard of support for nominees of the Republican Party than an individual who merely participates in a mass meeting, party canvass, convention or primary. Therefore, a member of an Official Committee is deemed to have resigned his Committee position if he (a) makes a reportable contribution to and/or (b) allows his name to be publicly used by and/or (c) makes a written or other public statement in support of a candidate in opposition to a Republican nominee in a Virginia General or Special Election.**

By signing this form, I certify that I am a registered voter in Chesterfield County, have read and understand the requirements above and that I intend to support all nominees of the Republican Party during this election (for convention delegates) and/or during my two-year term as a member of the Chesterfield County Republican Committee. Also, I have read and understand other requirements herein including, but not limited to Article 1 of the *Plan of Organization* which states in part:

**A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.**
